

FEES AND BOOTH INFORMATION

Application fee: \$120 for each 10' x 10' space, refundable upon non-acceptance

Deadline: February 15, 2008 **Notification and Check Deposit:** First Week of March 2008

- A registration is a commitment to the two days and official hours of the Show.
- No refunds given for cancellation after acceptance.
- Artists sharing a space must each submit an application. Photocopies are permitted.
- Submitted slides must be representative of the work to be exhibited.
- Participating artists must supply their own booth and/or display.
- Booth location requests will be considered, but cannot be guaranteed.
- This is an outdoor show and electricity is not available.
- Booth locations, Artists' Reception tickets and other details will be mailed in April.
- The City of Bethlehem may require artists to acquire a \$25.00 vendor license for the weekend and to pay a minimal mercantile tax on sales. Please call 610/865/7022 for information.
- You must display a sales tax license at the show and collect 6% sales tax in PA.
- The Bethlehem Fine Arts & Crafts Show will be held rain or shine. Although tents are not required, artists should be prepared for the possibility of inclement weather.
- Artist set-up is on Main Street, the street will be closed to traffic during show hours.

ENTRY PROCEDURE:

Send the following application with three (3) slides representative of the work you will display and one (1) slide of your display booth. Mark slides clearly with your name and an arrow indicating the top of the image. Include description on separate sheet, if desired. Please include a self-addressed envelope with appropriate postage to cover the return of slides. Slides of participating artists will be returned at the show.

ELIGIBILITY:

Original works by professional and amateur artists. Objects made from commercial kits or commercially available plans are not acceptable. The Fine Arts & Crafts Show Committee requires that the majority of exhibited works be originals and not commercially reproduced prints.
